

**A BILL**

To amend the Food Security Act of 1985 to encourage practices that benefit both soil and wildlife habitat by increasing payments to producers for such practices under the environmental quality incentives program and the conservation stewardship program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Saving Our Inter-  
5 connected Lives Act” or the “SOIL Act”.

1 **SEC. 2. ENVIRONMENTAL QUALITY INCENTIVES PROGRAM.**

2 (a) INCREASED PAYMENTS FOR CERTAIN PRACTICES  
3 RELATING TO SOIL AND WILDLIFE HABITAT.—

4 Section 1240B(d) of the Food Security Act of  
5 1985 (16 U.S.C. 3839aa–2(d) is amended by adding  
6 at the end the following:

7 “(8) INCREASED PAYMENTS FOR PRACTICES  
8 THAT BENEFIT BOTH SOIL AND WILDLIFE HABI-  
9 TAT.—Notwithstanding paragraph (2), the Secretary  
10 shall provide payment to producers at 90 percent of  
11 the cost associated with planning, design, materials,  
12 equipment, installation, labor, management, mainte-  
13 nance, or training for performing a practice that si-  
14 multaneously benefits both soil and wildlife habitat  
15 for projects identified by the Secretary as addressing  
16 both soil and wildlife habitat resource concerns, in-  
17 cluding practices that—

18 “(A) achieve alley cropping;

19 “(B) apply conservation cover;

20 “(C) apply contour buffer strips;

21 “(D) enhance or restore wetlands;

22 “(E) establish filter strips;

23 “(F) establish permanent vegetation to  
24 stabilize critical areas;

25 “(G) establish riparian herbaceous cover;

26 “(H) establish trees and shrubs;

- 1 “(I) establish wildlife habitat plantings;  
2 “(J) establish windbreaks;  
3 “(K) implement field borders;  
4 “(L) implement hedgerow planting;  
5 “(M) implement riparian forest buffers;  
6 “(N) improve forest stands;  
7 “(O) manage forage harvest;  
8 “(P) manage harvest of vegetation with  
9 grazing;  
10 “(Q) manage or establish stands of trees  
11 or shrubs in coordination with the management  
12 of understory plants or nontimber forest prod-  
13 ucts;  
14 “(R) manage pest and environmental im-  
15 pacts;  
16 “(S) manage residue and tillage manage-  
17 ment through no-till or reduced till;  
18 “(T) manage seasonal water for wildlife;  
19 “(U) manage upland and wetland habitat;  
20 “(V) plant cover crops;  
21 “(W) plant grassed waterways;  
22 “(X) plant stripercrops;  
23 “(Y) restore rare or declining natural com-  
24 munities; and  
25 “(Z) rotate crops.”.

1 (b) ESTABLISHMENT AND ADMINISTRATION.—Sec-  
2 tion 1240B(f)(2)(B) of the Food Security Act of 1985 (16  
3 U.S.C. 3839aa-2(f)(2)(B)) is amended by striking “prac-  
4 tices benefitting wildlife habitat under subsection (g)” and  
5 inserting “practices within projects that address a habitat  
6 resource concern”.

7 (c) EVALUATION AND PRIORITIZATION OF APPLICA-  
8 TIONS.—Section 1240C(b) of the Food Security Act of  
9 1985 (16 U.S.C. 3839aa-3(b)) is amended—

10 (1) in paragraph (3), by striking “and” at the  
11 end;

12 (2) in paragraph (4), by striking the period at  
13 the end and inserting “; and”; and

14 (3) by adding at the end the following:

15 “(5) that are developed for the purpose of ad-  
16 dressing both a soil and wildlife habitat resource  
17 concern.”.

18 **SEC. 3. CONSERVATION STEWARDSHIP PROGRAM.**

19 (a) EVALUATION AND RANKING OF STEWARDSHIP  
20 CONTRACT OFFERS.—Section 1240K(b)(1)(A) of the  
21 Food Security Act of 1985 (16 U.S.C. 3839aa-  
22 23(b)(1)(A)) is amended—

23 (1) in clause (ii), by striking “and” at the end;

24 (2) by redesignating clause (iii) as clause (iv);

25 and

1 (3) by inserting after clause (ii) the following:

2 “(iii) the degree to which the project  
3 addresses both soil and wildlife habitat re-  
4 source concerns; and”.

5 (b) SUPPLEMENTAL PAYMENTS FOR RESOURCE-  
6 CONSERVING CROP ROTATIONS, ADVANCED GRAZING  
7 MANAGEMENT, AND CO-BENEFIT ACTIVITIES FOR SOIL  
8 AND WILDLIFE.—Section 1240L(d) of the Food Security  
9 Act of 1985 (16 U.S.C. 3839aa–24(d)) is amended—

10 (1) in the section heading, by striking “AND  
11 ADVANCED GRAZING MANAGEMENT” and inserting  
12 “, ADVANCED GRAZING MANAGEMENT, AND CO-  
13 BENEFIT ACTIVITIES FOR SOIL AND WILDLIFE”;

14 (2) in paragraph (1), by adding at the end the  
15 following:

16 “(D) CO-BENEFIT ACTIVITY.—The term  
17 ‘co-benefit activity’ means a conservation activ-  
18 ity that—

19 “(i) addresses both soil and wildlife  
20 habitat resource concerns; and

21 “(ii) if implemented—

22 “(I) improves habitat for wildlife;  
23 and

1                   “(II) increases carbon sequestra-  
2                   tion in the soil and reduces green-  
3                   house gas emissions.”;

4           (3) in paragraph (2)—

5               (A) in subparagraph (A), by striking “or”  
6               at the end;

7               (B) in subparagraph (B), by striking the  
8               period at the end and inserting “; or”; and

9               (C) by adding at the end the following:

10              “(C) co-benefit activities.”; and

11           (4) in paragraph (3), by striking “or advanced  
12           grazing management” and inserting “, advanced  
13           grazing management, or co-benefit activities”.
