A BILL

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to maintain demographic information regarding veterans and publish such information on a website of the Department of Veterans Affairs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Every Veteran Counts
- 5 Act of 2021".

1 SEC. 2. FINDINGS.

2	Congress finds the following:
3	(1) The Department of Veterans Affairs is re-
4	sponsible for providing a variety of benefits and
5	services to more than 19,000,000 living veterans.
6	(2) Pursuant to section 527 of title 38, United
7	States Code, the Secretary of Veterans Affairs has
8	conducted the National Survey of Veterans to assess
9	the needs and sentiments of a statistically valid sam-
10	ple of all veterans.
11	(3) The Secretary has conducted this National
12	Survey of Veterans in the late 1970s, 1987, 1993,
13	2001, and 2010.
14	(4) The last survey conducted in 2010 included
15	veterans and other beneficiary groups, such as mem-
16	bers of the Armed Forces serving on active duty,
17	members of the reserve components of the Armed
18	Forces, military spouses, and surviving spouses of
19	such veterans and members.
20	(5) The 2010 survey included information on
21	demographics, awareness and utilization of benefits,
22	health status, military service, and employment.
23	(6) These surveys provide valuable information
24	on the veteran population to the Secretary, Con-
25	gress, Federal, State, and local governments, aca-

1 demic institutions, and various non-governmental or-2 ganizations that serve veterans. 3 (7) This information is used to inform policy-4 making efforts and to ensure the needs of the ever-5 changing veteran population are met. 6 (8) However, since 2010, the statutory frame-7 work for data collection has substantially evolved. 8 notably with the Foundations for Evidence-based 9 Policymaking Act (Public Law 115–435), the Data 10 Act (Public Law 113–139), and the Geospatial Data 11 Act (subtitle F of title VII of Public Law 115–254), 12 known collectively as the "Evidence Act", building 13 on previously enacted laws. 14 (9) Further, the Department, through the Na-15 tional Center for Veterans Analysis and Statistics, 16 has leveraged the vast amount of data generated 17 within the Department and collected by other Fed-18 eral partners to improve population-based descrip-19 tive, statistical, and predictive analytic products to 20 support the Secretary and in evidence-based policy-21 making, facilitate innovative and collaborative re-22 search, and empower modern business intelligence 23 applications. 24 (10) The Department has been a consistent 25 leader in the Federal Open Data program and offers

1	a platform for scaling access to useful data and in-
2	sight to external stakeholders.
3	(11) Notwithstanding these recent advances,
4	opportunities exist to strengthen the capability of
5	the Department to develop and disseminate action-
6	able insights into the veteran population through—
7	(A) developing enterprise-focused manage-
8	ment and improvements in the quality of ad-
9	ministrative data collected by the Department
10	through its delivery of benefits and services;
11	(B) increased access to data collected by
12	other Federal entities through more flexible and
13	efficient information sharing policies;
14	(C) increased use of publicly available and
15	commercially generated data; and
16	(D) maturing data management of the De-
17	partment.
18	(12) In line with the Evidence Act, it is incum-
19	bent upon the Secretary to regularly engage with
20	key stakeholders, including Congress, veterans serv-
21	ice organizations, advocacy groups, and open govern-
22	ment groups to—
23	(A) enhance the open data program of the
24	Department; and

1	(B) improve development and dissemina-
2	tion of relevant data assets and analytic prod-
3	ucts to provide more current, accurate, and use-
4	ful insights on veterans and their families.
5	(13) It is necessary for the Department to col-
6	lect, collate, and analyze all available data on vet-
7	eran demographics, and to share this data with Con-
8	gress and other stakeholders on an ongoing basis, in
9	an easily digestible format, to direct outreach and
10	align policy with the needs of the changing veteran
11	population.

17	"(i) rural or urban setting;
18	"(ii) distance to a facility of the Depart-
19	ment; and
20	"(iii) whether the veteran has access to
21	broadband service.
22	"(O) Any other information the Secretary de-
23	termines appropriate.
24	"(b) Data Retention Standards.—Demographic
25	data in the database under subsection (a) shall be—

1	"(1) anonymized to prevent the release of sen-
2	sitive personal information (as that term is defined
3	in section 5727 of this title); and
4	"(2) machine readable.
5	"(c) Website.—The Secretary shall maintain a pub-
6	licly accessible website of the Department that provides
7	access to the database under subsection (a). The Secretary
8	shall update such website not less frequently than once
9	each year.".
10	(b) Clerical Amendment.—The table of sections
11	at the beginning of such chapter is amended by inserting,
12	after the item relating to section 527, the following new
13	item:
	"528. Demographic data of veterans: collection; retention; publication.".
14	(c) Implementation Date.—The Secretary of Vet-
15	erans Affairs shall carry out section 528 of such title, as
16	added by this section, not later than 180 days after the
17	date of the enactment of this Act.
18	SEC. 4. REPORT ON DATA STRATEGY OF THE DEPARTMENT
19	OF VETERANS AFFAIRS.
20	(a) Report Required.—Not later than one year
21	after the date of the enactment of this Act, the Secretary
22	of Veterans Affairs shall submit to Congress a report de-
23	scribing the progress, challenges, performance, and oppor-
24	tunities of implementing the data strategy of the Depart-
25	ment of Veterans Affairs.

1	(b) Elements.—The report under this section shall
2	include the following:
3	(1) Qualitative and quantitative progress to-
4	wards strengthening data management of the De-
5	partment, including business and mission impact en-
6	abled by management of data as a strategic asset.
7	(2) Recommendations of the Secretary regard-
8	ing legislation that may accelerate data management
9	maturity of the Department.
10	(3) Progress and results in cataloging and
11	inventorying data assets of the Department and
12	using such assets to support—
13	(A) internal evidence-based policymaking;
14	and
15	(B) ethical and appropriate dissemination
16	of statistical aggregates, data-driven analysis,
17	and open data.
18	(4) Progress in implementing requirements
19	under chapter 35 of title 44, United States Code
20	(commonly known as the "Paperwork Reduction
21	Act"), and related data quality efforts to support
22	strategic management of data collected by the De-
23	partment.
24	(5) Efforts to move towards a rules-based,
25	transparent, Department-wide approach to manage-

1	ment, integration, and sharing of, and access to,
2	data.
3	(6) Recommendations of the Secretary regard-
4	ing adjustments to data requirements of the Depart-
5	ment.
6	(7) Information sharing agreements and out-
7	standing requirements with other Federal entities,
8	including gaps best addressed by the addition of sur-
9	vey questions to an existing Federal survey instru-
10	ment.
11	(8) Progress on recently enacted public laws,
12	Executive Orders, Presidential memoranda, and out-
13	standing recommendations of the Comptroller Gen-
14	eral of the United States or an inspector general as
15	it pertains to veteran population-based data collec-
16	tion, quality, integration, sharing, interoperability,
17	and analytics within the scope of improving and en-
18	suring equity in services to veterans, their families,
19	and other beneficiaries;
20	(9) A discussion of current risk assessments re-
21	garding data breaches and information security (as
22	those terms are defined in section 5727 of title 38,
23	United States Code) of the Department.

1	(10) Priority data requirements of the Depart-
2	ment, identified through consultation with the fol-
3	lowing entities:
4	(A) The Committee on Veterans' Affairs of
5	the Senate and the Committee on Veterans' Af-
6	fairs of the House of Representatives.
7	(B) The Congressional Budget Office.
8	(C) Veterans service organizations.
9	(D) The Advisory Committee on Minority
10	Veterans of the Department.
11	(E) The Advisory Committee on Women
12	Veterans of the Department.
13	(F) The Advisory Committee on Homeless
14	Veterans of the Department.
15	(c) Publication.—Not later than 30 days after sub-
16	mitting the report under this section, the Secretary shall
17	publish such report on the open data website of the De-
18	partment, with all metrics and data included in a machine
